Dear Troy City School District Community,

Once again this year, the Governor's proposed budget includes inequitable and insufficient aid to school districts, especially urban districts like ours, who are more dependent on State Aid. Our proposed Aid increase is less than 1% and, at this point, leaves us with a budget gap of \$2.5 million.

We need your help to advocate for Troy students!

I will be personally meeting with our legislators on March 7th, and I would like to bring with me as many letters from our school community as possible.
