WHEREAS, the Board of Education of the Enlarged City School District of Troy has the opportunity to purchase certain real property and improvements from the Sage Colleges, known as the Neff Center, bearing Tax Map No.(s) 112.21-13-5; 112.29-3-1 and 112.21-12-3, and consisting of approximately 15.97 acres, more or less (the "Premises") which the District proposes to use for school purposes; and

WHEREAS, the Sage Colleges has offered to sell the Premises to the District for \$1,100,000.00 and the Board has determined that a purchase of the Premises at this price represents the fair market value of the Premises and is in the best interests of the District; and

WHEREAS, the purchase of real property by the School District requires voter approval;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education of the Enlarged City School District of Troy hereby approves the offer to purchase from the Sage Colleges of the Premises known as the Neff Center at the purchase price of \$1,100,000.00, subject to approval of the purchase by the qualified voters of the District at a public referendum and any required municipal or governmental approvals; and

BE IT FURTHER RESOLVED, that the Board of Education of the Enlarged City School District of Troy hereby approves a Purchase and Sale Agreement ("Agreement") for the purchase of certain real property and improvements from the Sage Colleges, known as the Neff Center, bearing Tax Map No.(s) 112.21-13-5; 112.29-3-1 and 112.21-12-3, and consisting of approximately 15.97 acres, more or less (the "Premises") at the purchase price of \$1,100,000.00, subject to the contingencies contained in the Agreement, including a contingency for approval of the purchase by the voters at a District meeting, and any required municipal or governmental approvals, and hereby authorizes the President of the Board of Education to execute the

Agreement and the Escrow Agreement referenced therein; and

BE IT FURTHER RESOLVED, that the Board of Education of the Enlarged City School District of Troy hereby authorizes the President of the Board of Education to execute such other and further documentation as may be necessary in furtherance of and in order to effectuate the Agreement, and further instructs the Superintendent of Schools and other appropriate District officials to proceed with the implementation of all steps reasonably necessary and appropriate to allow for the District's performance of the Agreement.
