# II. Non-Action Items

## A. Alternative Learning Program Principal's Presentation

Mr. James Canfield gave an annual update regarding the Alternative Learning Program (ALP) at School 12. He said their mantra is "Every mind. Every heart." Mr. Canfield and his staff believe all students can learn. Their instruction is rigorous and staff is continuously cultivating caring relationships. Every day matter and student attendance is very important. He reported that 87 students (66%) are in good academic standing and 20% make honor roll. ALP curriculum offers APEX classes and 40 students are enrolled. Suspensions for 2018/19 are high at 208. There are 76 students in the 3-6 PM program. Mrs. Beth Von Eitzen, Mr. Trevor Taylor and Mr. Norris Benbow provided information about other aspects of the ALP program. Senior students Seth Bussing and Kemiya Pryor gave powerful speeches regarding the way ALP has impacted their lives. This year students were able to travel to Philadelphia and had a wonderful experience. Mr. Canfield thanked the Board and administration for their support.
