General fund revenues were consistent, increases are due to receiving state aid payments. Expenditures are on target with last year. Ten of our grants have been approved and we are waiting on four. Final expenditure reports have been submitted so payments are coming in. Projections will begin next month. A note on the banking, they lowered our interest rates but will still result in additional revenue. All accounts have been reconciled.

1. RATIFICATION OF "RESOLUTION OF NECESSITY" ADOPTED ON OCTOBER 16, 2019

WHEREAS, at its meeting of October 16, 2019, the Board of Education approved the following Resolution: "A Resolution specifying necessity for the acquisition of three parcels of land and the buildings and improvements located thereon and the construction of additions to and reconstruction of such buildings, improvements and sites, buildings and improvements, the renovation of the existing Troy High School technology wing and related site work, the construction of minor additions to and reconstruction of various school district buildings, facilities, improvements and sites, and, in the case of each of the components of the project, the acquisition of original furnishings, equipment, machinery or apparatus required for the purpose for which such buildings, facilities, improvements and sites are to be used, such buildings, improvements and sites located in the City of Troy, Rensselaer County, New York" (hereinafter referred to as "Resolution of Necessity"); and

WHEREAS, the preamble to the aforementioned Resolution of Necessity incorporated by reference an Exhibit "A" containing the metes and bounds description of the three parcels of land to be acquired; and

WHEREAS, the said Exhibit "A" was inadvertently omitted from the Board agenda of October 16, 2019; and

WHEREAS, although there is no reason to question the validity of the action taken by the Board to approve the Resolution of Necessity, the Board feels that it is appropriate to ratify and affirm its previous approval in order to ensure a complete and accurate record of the entire resolution, including Exhibit "A", that was approved on October 16, 2019;

NOW, THEREFORE, BE IT RESOLVED, that upon the recommendation of the Superintendent of Schools, the Board of Education of the Enlarged City School District of Troy hereby affirms and ratifies the Resolution of Necessity previously adopted on October 16, 2019, which includes the language of the Resolution and Exhibit "A" both of which are annexed hereto.

2. Extension of Board Clerk Appointment

WHEREAS, on August 7, 2019, the Board of Education appointed Theresa Kaniff to serve as Board Clerk through December 31, 2019 and approved a stipend for the performance of Board Clerk duties for the period from July 1, 2019 through December 31, 2019; and

WHEREAS, the Board of Education has determined to extend the appointment of Ms. Kaniff as Board Clerk through June 30, 2020;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education hereby extends the appointment of Theresa Kaniff as Board Clerk through June 30, 2020; and

BE IT FURTHER RESOLVED, that Ms. Kaniff shall receive an additional stipend in the amount of \$10,000 for

the performance of Board Clerk duties for the period from January 1, 2020 through June 30, 2020.

3. Extension of Additional Duties by Secretary to the Superintendent

WHEREAS, on August 7, 2019, the Board of Education approved an Amendment to the Terms and Conditions Agreement for the Secretary to the Superintendent ("Amendment") and a stipend payment in recognition of the performance of additional assigned duties as outlined in the Amendment, for the period from July 1, 2019 through December 31, 2019; and

WHEREAS, said Amendment authorized the Board of Education, in its discretion, to elect to extend said additional duties through June 30, 2020, and to provide an additional stipend of \$5,000 in such case;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education hereby extends the performance of the additional duties performed by the Secretary to the Superintendent, as outlined in the Amendment, through June 30, 2020; and

BE IT FURTHER RESOLVED, that the Secretary to the Superintendent shall receive an additional stipend in the amount of \$5,000 for the performance of the additional duties outlined in the Amendment for the period from January 1, 2020 through June 30, 2020.
