#### **B. EXECUTIVE SESSION**

At 5:30 pm Mr. Schofield made a motion for Executive Session for pending litigation. Invited in were Mr. Carmello, Mr. Hotaling and Mrs. O'Grady-Parent.

#### C. PUBLIC SESSION

At 6:05 pm Mr. Schofield called the meeting to order with the Pledge of Allegiance.

Announcements: (1) Superintendent Carmello delivered nearly 5,000 signed letters demanding equitable State Aid early this month. Thank you to everyone who helped advocate for our kids; (2) Congratulations to the Troy High Girls Basketball Team for being named a 2016-2017 NYSPHSAA Scholar Athlete Team and (3) The Troy High School Robotics team participated in the NY Tech Valley Regional's first competition at RPI this weekend. Troy's team made it all the way to semi-finals before being defeated.

#### II. Non-Action Items

#### A. TROY HIGH SCHOOL PRINCIPAL'S PRESENTATION

Mr. Joseph Mariano, Jr., THS Principal, gave a power point presentation. He reviewed the District's goals and said Troy High is especially focused on graduation rates and the Code of Conduct. Troy High's vision is to make THS a place where all students are inspired to achieve success and are supported to perform to the best of their ability.

THS is proud that its graduation rate has increased to 83%; up 7% from last year and higher that other NYS high-needs urban/suburban districts which has a 70% graduation rate. This is a District-wide accomplishment. Graduate rates by ethnicity have also increased: Hispanic Students are 89% from 65% in 2015; African American students are 85% from 75% in 2015. Troy is above the state average of 68% for both groups. Mr. Mariano gave a breakdown of test scores for regents courses. There has been in increase in all regents results, except Geometry which remains low since the implementation of Common Core. He attributes THS success to his staff and additional supports.

Distance Learning program has grown at THS. There are also several new courses offered at THS this year: digital photography, creative crafts, textile fashion and computer programming. Troy's Mastermind students recently won their competition and students were congratulated. Efficacy initiative had a very successful launch and students are responding well.

## VI. Budget Presentation

#### 2017-18 Budget Overview - Draft 2

Mr. Carmello began his presentation with the budget goal to be fiscally responsible and educationally sound; this will be more difficult this year than in the recent past. Draft 1 of the budget was at \$113,587,468 with a gap of \$2,597,042 (presented on February 15th). Draft 2 of the budget is \$113,040,797 with a gap remaining of \$2,050,371. The total change from Draft 1 is \$546,671. Revenues have not changed. We are waiting on State budget numbers.

<u>Tax Cap</u> - This year's tax cap is .45% or \$160,000; this is less than half a percentage point. It will be difficult to go below the tax cap this year. Foundation Aid is still over \$9 million underfunded. We are in a holding pattern until State aid numbers are available.

State Assembly and Senate bills have been released. Assembly bill shows an increase by \$1.8 billion over 2016-17; including \$1.4 billion increase in Foundation Aid. A tax cap provision would codify the changes to the tax cap originally made in 2015 which would help Troy. Community Schools funding is a "set- aside" item and would be funded as a separate aid category. Senate bill shows an increase of \$1.2 billion over 2016-17, including a \$906 million increase in Foundation Aid. It does not include a phase-in schedule for the Foundation Aid formula. Community Schools would have increased funding of \$125 million over 2016-17. This is \$75 million more than the Executive's proposal. The Senate bill accepts the Executive's proposal on charter schools, including "unfreezing" charter school basic tuition. Troy has one of the highest tuition rates in the area at \$15,986. If unfrozen the new rate would be \$13,700 and this would close our gap.

<u>Discussion:</u> Mr. Tuttman asked how much we receive in revenue from a PILOT. Mr. Carmello answered approximately \$1 million payment to school. Ms. Marro-Giroux asked what is the difference between unfrozen tuition and reimbursement. Mr. Hotaling answered reimbursement comes in the following school year and causes a gap.

Other Considerations - Mr. Carmello said he had a conversation with the Mayor about School Resource Officers (SROs). We have them now in TMS and THS and will continue to need them. We are asking the Mayor to split the cost. Discussions are still taking place and SROs do not appear in the Draft 2. We are still waiting on final numbers for prescription drug rates. Tier 2 and Tier 3 requests would greatly benefit our students but cannot be put in the budget until we have closed the gap.

Advocacy Efforts - Mr. Carmello and Mr. Hotaling had several face-to-face meetings with our legislators and have ongoing communication with elected officials through out the year. They delivered 5,000 advocacy letters from our stakeholders. Mr. Tuttman said he applauds Mr. Carmello's efforts.

Capital Reserve Fund - Mr. Carmello stated the Building Condition Surveys (BCS) identified over \$50 million in needed improvements to our buildings. Last May the voters passed a \$23.3 million project to address the greatest needs in the District. The Capital Project Committee has confirmed numerous additional areas of need: School 16 improvements, classroom space, storage, educational window replacements, pool area reconstruction, etc. We need to plan for the future and establish a Capital Reserve to help cover the local share of any future capital projects. Voter approval is needed to establish the fund and authorize spending. The Board will have a special Board meeting next week (March 27 at 6 pm) to discuss further and approve a resolution within 45-day notice needed to appear on the May ballot.

<u>Discussion:</u> Mr. Schofield asked if there is a limit on how much was can borrow. Mr. Hotaling responded there is a constitutional debt limit that is calculated. We are approaching that and can only exceed it with 60% majority vote. Ms. Marro-Giroux asked if we should use a higher amount in case costs increase over the term; she would like to discuss different scenarios at the next meeting. Mr. Hotaling said a higher amount could risk approval by the voters.

Mr. Carmello concluded the presentation by saying the budget development calendar may need to be modified depending on when we have State aid information.
