## B. Executive Session

At 5:31 pm Mr. Mayo, President, made a motion for Executive Session for discussion of pending litigation. Invited were Mr. Carmello, Dr. Watson, Mr. Hotaling, Mrs. Miaski, Ms. Kathy Ahearn and Mr. Anthony Fasano.

#### II. Non-Action Items

A. School 18 Principal's Presentation - V. DonVito-MacPhee

School 18 Principal, Ms. DonVito-MacPhee, begins by thanking the Board for their continued support. She explains the School 18 building goals which include providing high quality academic and behavioral support, focus on respect, communication and relationship building, as well as using data to drive instruction to promote. Ms.

DonVito-MacPhee shares the NYS ELA and Math results which have steadily increased over the last five years. Mrs. Napolitano speaks to an increased focus on decreasing student absences this year, by collaborating with transportation, daily phone calls and home visits with families. Student discipline has also decreased this year by 58% compared to last year as a result of implementing clear expectations and focusing on student needs. Mrs. DonVito-MacPhee continues to explain that the implementation of the Teacher's College reading and writing program has made a huge impact at School 18.

Instructional coaches, Ms. Clark and Ms. Testo discussed how the implementation of the Teacher's College reading and writing program has hugely benefited the students at School 18 by using the workshop model with coaching relationships. Coaching cycles consist of goal setting, learning, observation, data collection and reflection. The instructional coaches work closely with teachers in the classroom allowing teachers to develop performance similarities among students and make changes to improve instruction. Staff also work with the Teacher's College staff developers and attend professional development events at the Teacher's College to help collaborate with staff and determine next best steps. Mrs. St. John explains her personal experiences using a research based protocol from the Teacher's College called Massive Practice. She explains how the learning coaching cycle was very valuable to her teaching, and saw some really great increases to her English Language Learners improvements with reading levels. School 18 students, Jayne Babcock, Santina Rizzo, Makenna Croll, taught a problem and solution lesson to their younger siblings, mirroring teachers' learning model of teaching in the classroom.

Ms. DonVito-MacPhee ends the presentation by thanking the Board again for their continual support at School 18.

# B. Budget Discussion - J. Carmello

Mr. Carmello explains an overview of the school budget process. He begins with the mission statement that drives all the decisions made in Troy especially during budget time. Budget calendar was approved at the December 14th meeting. Beginning February 5th, there will be a budget discussion every first Wednesday of the month until the Budget Vote in May. A Citizen's Advisory committee has been approved and will be joining these meetings. Six or seven years ago, the district decided to use data to drive decisions and will continue to use this process to form this year's budget.

The budget is formed by being educationally sound and fiscally responsible. Educationally sound means we do what the students in Troy need. Fiscally responsible means that we need to be good stewards of the taxpayers money. Trying to balance these two things is what makes decisions difficult. The district has been below the tax cap for the last eight years and continues to look for other funding sources with grants. Over the last seven years, district wide the ELA and Math results have continued to improve. The high school's graduation rate is something we're very proud of with an overall rate of 87% for 2018.

State aid is very important to districts like Troy in which 61% of our revenues come from. The foundation aid formula the state uses is an underfunded formula. This school year we are underfunded almost \$11,000,000. Just last year more than 40% of districts statewide received more than the formula stated. The Education Conference Board, NYSSBA, NYSASBO and the Board of Regents are asking the state to increase school aid by approximately \$2 Billion. We must wait for the Governor's executive budget to be released to form our school budget.

We're beginning to put the first budget draft together and have begun our administrators meetings to talk about their building budgets. The first budget draft will be presented at the February 5th board meeting. Our budget vote is May 19, 2020.
