RESOLVED, that the proposed budget of expenditures of the Enlarged City School District of Troy, New York for the 2020-2021 school year in the amount of \$113,651,375 and for the purposes shown in the statement of estimated expenditures adopted by the Board of Education be and the same hereby is approved and the amount thereof shall be raised by a levy of a tax upon the taxable property of the school district, after first deducting the monies available from state aid and other sources as provided by the law.
