- Oversee and coordinate regular meetings of all stakeholders
- Oversee and manage program budget
- Provide District Office with regular reports
- Complete SED required reports
- Any other responsibilities as deemed necessary by the Superintendent or Assistant Superintendent
- Hire, train, develop and supervise staff of the summer program; process time sheets
- Recruit and retain students for a total of 6 weeks
- Work directly with students during academics and recreation
- Design and assist in implementing a social component for at least a total of 1 hour daily (topics include but are not limited to: healthy living, peer pressure, gang and violence prevention)
- Supervise students; organize academic and social programming
- Assist in academic, social and recreational program implementation
- Complete data entry for Annual Performance Report
- Communicate with the bus company in regard to transportation
- Provide each participant a respectful environment that is culturally sensitive
- Feature project-based and experiential activities while offering high quality academic support
- Integrate opportunities for personal responsibility, resiliency and self-direction such as decision making in programming
- Engage students in community service, giving them a sense of purpose and role in the community
- Provide opportunities of literacy and other educational experiences for participants and their families
- Establish and build relationships with the arts and cultural community institutions to enhance and expand program offerings
- Gather data for State-mandated reporting, as well as establish program efficiency through a case study with Research Works, Inc.
