II. Non-Action Items

A. Superintendent Update - J. Carmello

Mr. Carmello gave a brief Covid update regarding the home tests Governor Hochul spoke of late last week. These tests did not arrive at our BOCES until Saturday, January 1st and were received by the district Monday afternoon. During a meeting with the Governor and state-wide Superintendents, the Governor recognized it was impossible to hand these tests out prior to students returning to school, so the district will be sending tests home with students along with a letter to families this week. The letter will explain that these tests are a piece of mind

screening tool for families, but are not official tests recognized by Rensselaer County. If a student does receive a positive result on one of these at home tests they are still required to follow up with a lab, pharmacy or doctors office for another PCR test before our official quarantine procedures come into play.

Additionally, Mr. Carmello expressed that at the first meeting of the month he wants to highlight different programs that are going on throughout the district. He then asked Dr. Watson to continue with a College and Career Readiness Update. Dr. Watson began by explaining that there have been College and Career Exploration Liaisons appointed at each building throughout the district. These liaisons have been assessing every student with either Paws in Jobland or Naviance programs to find what each student's passion is. Their next steps will be adults within their buildings sharing their college pathways. Some schools have already dedicated different hallways to colleges such as RPI, Howard, UAlbany and Hampton. The goal is to start students thinking about their future. The liaisons will be working to group students together by similar interests and set up opportunities within that specific career role. We are hoping to invite guest speakers, mentors and set up internships to help raise the level of readiness for our students to find their passion.
