3. SEQRA Determination

WHEREAS, the Board of Education (the "Board") of the Enlarged City School District of Troy (the "District") is proposing to undertake a capital project consisting of reconstruction and renovations of various school buildings, facilities and sites, acquisition of original furnishings, equipment, machinery or apparatus required for the purpose for which such buildings, facilities and sites are to be used and payment of costs incidental thereto, at a maximum cost of \$46,000,000 (the "Proposed Action"); and

WHEREAS, the Proposed Action entails the renovation, maintenance, repair, replacement, reconstruction and/or rehabilitation involving no substantial changes or expansion beyond 10,000 square feet of existing structures and/or facilities; and

WHEREAS, the Proposed Action is a routine activity of the District; and

WHEREAS, the Board has considered information and documentation which describes the design and intent of the Proposed Action;

NOW THEREFORE, BE IT RESOLVED, that the Board of Education of the Enlarged City School District of Troy, based upon the record before it, including the general, specific and detailed knowledge of the Board of the Proposed Action, and under the applicable standards of the New York State Environmental Quality

Review Act ("SEQRA") and 6 NYCRR Part 617.5, hereby declares that the Proposed Action is a Type II action, and that no further action is required to satisfy the requirements of SEQRA.

BE IT FURTHER RESOLVED, that this resolution takes effect immediately.

4. Bond Resolution

BOND RESOLUTION DATED APRIL 17, 2024 OF THE BOARD OF EDUCATION OF THE ENLARGED CITY SCHOOL DISTRICT OF TROY AUTHORIZING NOT TO EXCEED \$39,000,000 AGGREGATE PRINCIPAL AMOUNT OF SERIAL GENERAL OBLIGATION BONDS AND THE EXPENDITURE OF \$7,000,000 FROM THE CAPITAL RESERVE FUND TO FINANCE THE RECONSTRUCTION AND RENOVATIONS OF VARIOUS SCHOOL DISTRICT BUILDINGS, FACILITIES AND SITES, THE ACQUISITION OF ORIGINAL FURNISHINGS, EQUIPMENT, MACHINERY OR APPARATUS REQUIRED FOR THE PURPOSE FOR WHICH SUCH BUILDINGS, FACILITIES AND SITES ARE TO BE USED, AT AN ESTIMATED MAXIMUM COST OF \$46,000,000, LEVY OF TAX IN ANNUAL INSTALLMENTS IN PAYMENT THEREOF, THE EXPENDITURE OF SUCH SUMS FOR SUCH PURPOSE, AND DETERMINING OTHER MATTERS IN CONNECTION THEREWITH.

BE IT RESOLVED BY THIS BOARD OF EDUCATION AS FOLLOWS:

Section 1. The Enlarged City School District of Troy (the "School District") shall reconstruct and renovate various School District buildings, facilities and sites, acquire original furnishings, equipment, machinery, or apparatus required for the purpose for which such buildings, facilities and sites are to be used and pay costs incidental thereto, at a maximum cost of \$46,000,000, as more particularly described in Section 3 hereof.

Section 2. The School District is hereby authorized to issue its serial general obligation bonds (the "Bonds") in the aggregate principal amount of not to exceed \$39,000,000 pursuant to the Local Finance Law of the State of New York and expend \$7,000,000 from the Capital Reserve Fund, in order to finance the class of objects or purposes described herein.

Section 3. The class of objects or purposes to be financed pursuant to this Resolution (the "Purpose") is the reconstruction and renovation of various School District buildings, facilities and sites, the acquisition of original furnishings, equipment, machinery or apparatus required for the purpose for which such buildings, facilities, and sites are to be used and the payment of costs incidental thereto.

Section 4. It is hereby determined and declared that (a) the maximum cost of the Purpose, as estimated by the Board of Education, is \$46,000,000, (b) no money has heretofore been authorized to be applied to the payment of the cost of the Purpose, and (c) the School District plans to finance the cost of the Purpose from funds received from the State of New York as building aid, the expenditure of \$7,000,000 from Capital Reserve Fund and funds raised by the issuance of the Bonds and bond anticipation notes hereinafter referred to.

Section 5. It is hereby determined that the Purpose is one of the class of objects or purposes described in Subdivision 97 of Paragraph a of Section 11.00 of the Local Finance Law, and that the period of probable usefulness of the Purpose is thirty (30) years.

Section 6. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the sale of the Bonds, including renewals of such notes, is hereby delegated to the President of the Board of Education, the chief fiscal officer.

Section 7. The power to further authorize the issuance of the Bonds and bond anticipation notes and to prescribe the terms, form and contents of the Bonds and bond anticipation notes, including the consolidation with other issues and the use of substantially level or declining debt service, subject to the provisions of this Resolution and the Local Finance Law, and to sell and deliver the Bonds and bond anticipation notes, is hereby delegated to the President of the Board of Education. The President of the Board of Education is hereby authorized to sign and the District Clerk is hereby authorized to attest any Bonds and bond anticipation notes issued pursuant to this Resolution, and the District Clerk is hereby authorized to affix to such Bonds and bond anticipation notes the corporate seal of the School District.

Section 8. The faith and credit of the School District are hereby irrevocably pledged for the payment of the principal of and interest on the Bonds and bond anticipation notes as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year. There shall be levied annually on all taxable real property of the School District, a tax sufficient to pay the principal of and interest on such obligations as the same become due and payable.

Section 9. This Resolution shall constitute the declaration of the School District's "official intent" to reimburse expenditures authorized by Section 1 with proceeds of the Bonds and notes, as required by United States Treasury Regulation Section 1.150-2.

Section 10. This Resolution shall be published in summary from, when effective, by the District Clerk together with a notice in substantially the form prescribed by Section 81.00 of said Local Finance Law, and such publication shall be in each official newspaper of the School District. The validity of the Bonds or of any bond anticipation notes issued in anticipation of the sale of the Bonds may be contested only if such obligations are authorized for an object or purpose for which the School District is not authorized to expend money, or the provisions of law which should be complied with at the date of publication of this Resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution.

Section 11. This Resolution shall become effective immediately upon approval thereof by the voters of the School District at a special meeting of such voters.

5. Proposition for Voters at the Annual District Meeting

RESOLUTION DATED APRIL 17, 2024 OF THE BOARD OF EDUCATION OF ENLARGED CITY SCHOOL DISTRICT OF TROY AUTHORIZING A PROPOSITION TO BE PRESENTED TO THE VOTERS AT THE ANNUAL DISTRICT MEETING.

BE IT RESOLVED BY THE BOARD OF EDUCATION OF ENLARGED CITY SCHOOL DISTRICT OF TROY (the "School District") that the following proposition be presented to the voters at the annual meeting of such voters to be held on Tuesday, May 21, 2024:

PROPOSITION

SHALL the bond resolution adopted by the Board of Education of Enlarged City School District of Troy on April 17, 2024 which authorized (1) the reconstruction and renovation of various School District buildings, facilities and sites, the acquisition of original furnishings, equipment, machinery or apparatus required for the purpose for which such buildings, facilities, and sites are to be used and the payment of costs incidental thereto, at a maximum aggregate cost of \$46,000,000; (2) expenditure of such sum for such purpose, including the expenditure of \$7,000,000 from the Capital Reserve Fund; (3) levy of the necessary tax therefor (including the levy of a tax to pay the interest on obligations when due) to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education in accordance with Section 416 of the Education Law, taking into account state aid received and the amount expended from the Capital Reserve Fund; (4) in anticipation of the collection of such tax, issuance of bonds and notes of the District at one time or from time to time in the principal amount not to exceed \$39,000,000, be approved?

BE IT FURTHER RESOLVED that the District Clerk is hereby directed to include notice of such proposition in the notice of the annual meeting.

BE IT FURTHER RESOLVED that the Board of Education hereby ratifies any publication of such proposition prior to the date hereof.

BE IT FURTHER RESOLVED, that this resolution takes effect immediately upon its adoption.

6. Resolution of Necessity

A RESOLUTION SPECIFYING THE NECESSITY FOR THE RECONSTRUCTION AND RENOVATION OF VARIOUS SCHOOL DISTRICT BUILDINGS, FACILITIES AND SITES, SUCH BUILDINGS, FACILITIES AND SITES LOCATED IN THE CITY OF TROY, RENSSELAER COUNTY, NEW YORK.

WHEREAS, it is the judgment of the Board of Education of Enlarged City School District of Troy, Rensselaer County, New York, that the needs of Enlarged City School District of Troy (the "School District") require the reconstruction and renovation of various School District buildings, facilities, and sites, the acquisition of original furnishings, equipment, machinery or apparatus required for the purpose for which such buildings, facilities and sites are to be used and payment of costs incidental thereto (collectively, the "Project"), which buildings, facilities and sites are located within District, in order for the School District to continue to utilize said School District buildings, facilities and sites as school and related facilities; and

WHEREAS, the Board of Education of the School District has been presented with a proposal for the aforesaid Project at a maximum estimated cost not to exceed \$46,000,000; and

WHEREAS, Section 2512 of the Education Law requires that whenever in the judgment of the Board of Education a building or property, or both, are to be reconstructed, constructed or otherwise improved, such Board of Education shall prepare a resolution specifying, in detail, the necessity therefor and the estimated cost of the funds necessary for such purposes;

NOW, THEREFORE BE IT RESOLVED, by the Board of Education of the District, as follows:

Section 1. It is determined that the Project, as more fully described in the preamble hereof, is necessary for the following reasons:

- A. To enhance the educational opportunities of the District's students.
- B. To enhance and improve the health, safety and welfare of the students and staff of the District.
- C. To address capital maintenance items required in order to maintain the integrity and expected life of the District's buildings and sites.
- D. To enhance the energy efficiency of the District's buildings, facilities and sites.

Section 2. It is hereby estimated that the amount of funds necessary for the aforesaid purposes are as set forth in the preamble hereof and shall not exceed the sum of \$46,000,000.

Section 3. This resolution shall take effect immediately.
